On Sept. 29, 2008, United Cooperative Services (co-op) adopted a resolution initiating a rulemaking project to consider and determine whether to implement federal ratemaking standards under the Public Utility Regulatory Policies Act of 1978 (PURPA), as amended by the Energy Independence and Security Act of 2007 (EISA), Public Law No. 110-140, 121 Stat. 1492 (2007) to: I) integrate energy efficiency into the co-op's integrated resource plans and establish cost-effective energy efficiency as a priority resource; 2) establish electric rates to align utility incentives with the delivery of cost effective energy efficiency and to promote energy efficiency investments; 3) consider smart grid investments; and 4) give co-op members direct written or electronic access and other interested persons limited access to information on time-based electricity prices at wholesale and retail, prices and usage on at least a daily basis, and sources of power provided by the co-op. The proceeding has been designated Project No. 2008-TXI64-0001, Proceeding to Consider and Determine Whether to Implement the Federal Ratemaking Standards for Integrated Resource Planning, Rate Design Modifications to Promote Energy Efficiency Investments, Consideration of Smart Grid Investments, and Smart Grid Information pursuant to I6 U.S.C. § 2621(d)(I6), (17), (16) and (17) as amended by Pub. L. No. 110-140, 121 Stat. 1492 (2007). Persons interested in the proceeding are invited to notify the co-op of their intent to participate in the project and to submit comments, data, views, arguments, and other evidence on the standards being considered.
